

TASTING TABLE 2017 FLOATING FARMHOUSE SWEEPSTAKES OFFICIAL RULES

*NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. MUST BE 21 TO ENTER.
