

TASTING TABLE BRANDLESS PANTRY SWEEPSTAKES

OFFICIAL RULES

*NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. **ELIGIBILITY:** Tasting Table Brandless Pantry 2018 Sweepstakes ("Sweepstakes") is open only to legal residents of the forty nine (49) United States and the District of Columbia (void in Rhode Island, Puerto Rico, all U.S. territories and possessions and all overseas military installations) who are at least twenty one (21) years of age or older as of May 28, 2018. All employees of TDT Media Inc., doing business as Tasting Table ("Sponsor") and Brandless, Inc ("Partner"), their affiliates, sales representatives, licensees or agents (all of the foregoing, collectively, "Sweepstakes Entities"), and their immediate family members (spouse, parent, child, sibling and their respective spouses) and those living in the same household of each (whether legally related or not), are ineligible to enter or win the Sweepstakes.
