

## #TTVacationDays January 2018

### Official Rules

Please read the Official Rules and Regulations ("Official Rules") of the Tasting Table Vacation Days Contest January 2018 ("Contest") sponsored by TDT Media Inc. dba Tasting Table, New York, NY ("Tasting Table"). As a condition of entry into this contest, the entrant agrees to accept and comply with the Official Rules and agree with decisions made by Tasting Table and waive any right to claim ambiguity in the Contest or these Official Rules.

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS CONTEST. THE ODDS OF WINNING DEPEND UPON THE NUMBER OF ELIGIBLE ENTRIES RECEIVED DURING THE CONTEST PERIOD.**

**ELIGIBILITY:** The Contest is available only to legal residents of the States of the United States, who are 21 years or older at the closing date of the Contest, except for residents of Rhode Island and Puerto Rico ("Entrant").
